KENDRA BHAVAS AND THE TEXTILE BUSINESS

ABSTRACT

People approach Astrologers to identify the best areas for businesses to thrive and grow. It becomes the bounden duty of the Astrologer to identify suitable business to the native of the horoscope. After analyzing the significations of 12 Bhavas and 9 Planets, it is concluded that the four Kendra Bhavas 1, 4, 7, 10 (Quadrants) play a role of trading and that the Planets, Moon and Venus are closely related to the textile. In order to suggest textile business to a client, 7 rules are framed within which an Astrologer can more precisely predict this business. The study of 100 horoscopes made it clear that the Kendra Bhavas, the Moon and Venus are the primary cause in the horoscope for the textile business. This is explained in this article in detail.

INTRODUCTION

Origin and growth of the textile and textile business

The first need of human beings is food and clothing. *"Then kadal valaagam podhumai inriyum Venkudai nizhatriya orumaiyorkkum Nadunaal yaamatthum pagalum thunjaan Kadumaap paarkkum kallaa oruvarkum Unpadhu naazhi uduppavai irande'': Purananuru: 189* The poet "Nakkeerar" in "Purananuru" narrates that the essential needs of the man are food and clothing, whether he is an emperor or an uneducated hunter. When human being, who evolved from ape into man

or woman, felt the need to hide his nudity, they used leaves, foliage, bark and animal skins as clothing.

January – June

The "Thirumurukaatruppadai" and "Sangam" literature attests to the fact that women wore bark, foliage and flowers tied to a string.

Later, they knew how to get cotton from cotton seeds, spinning yarn and weaving garments.

The garments were woven of cotton and silk thread. The carpets were woven with rat hair. This can be understood from the following poem of "Silappadhikaaram".

"Noolinum mayirinum nuzhainoor pattinum Paalvagai theriyaap pannooradukkatthu

Narumadi serintha aruvaiveedhi"

The garments were called Kalingam as they were imported from Kalinga nation. The literature also says that silk came to Tamil Nadu from China and cotton garments from Kalinga.

Development of the textile business

The "Industrial Revolution", yielding greatest technological, economical and civilization change in the world, first appeared in England between the years 1750-1850. The Industrial Revolution began in the 20th century in Asian countries such as India and China. The industrial system appeared around the world only after World War II.

As a result of the Industrial Revolution, technological education expanded. Starting with the cotton spinning mills and mechanizing the various handicrafts, people created new methods to produce ingredients in large numbers, cheaply.

Weaving

The textile industry was the first to gain momentum with new mechanical inventions.

In the year 1733, John Kay invented the 'flying shuttle'. This increased the speed of fabric weaving. Thus, the demand for yarn increased.

In the year 1764, James Hargreaves invented 'Spinning Jenny'. In the year 1779, Samuel Crompton invented Spinning Mule. This created a high demand for the cotton yarn.

In the year 1769, James Watt invented the new steam engine. Thus steam power was used instead of horse and water power in the textile factories.

In the year 1785, the 'Power loom' was invented by Edmund Cartwright. This introduced the large-scale weaving method.

In the year 1793, Eli Whitney invented the Cotton Gin to separate cotton from seeds. This resulted in availability of a large quantity of raw cotton for textile production.

In the year 1846, Elias Howe invented the Sewing Machine.

Indian Textile Industry

The Indian textile industry has a long tradition. Handloom cloths were on sale even before the arrival of the Englishmen. After the Industrial Revolution, India was used by the British as a textile manufacturing Centre. But later, Gandhiji used handloom as a tool for the freedom struggle. The textile industry has been growing as a major industry since independence.

In the year 1854, India's first cotton textile mill was opened in Mumbai. In the year 1861, the first cotton textile mill was opened in Ahmadabad. Later Ahmadabad emerged as a textile city. The total number of textile mills increased from 178 in the year 1901 to 417 in the year 1945. Latest survey of total number of textile mills in India at present is 1719.

The textile sector is projected to be the second largest employer after agriculture.

ASTROLOGY AND TEXTILE BUSINESS

Astrology in Sanskrit is referred the houses (signs) as 'Bhava' meaning a mode of being, essence or feeling, and are thus, in Vedic Astrology, a changing twelve-fold division of the zodiac circle, which depend upon the position of the earth in its daily rotation relative to the heavenly bodies. As the earth rotates itself during the course of the day, the whole zodiac gradually rises in the East and sets in the West. The point rising in the East at the time of the birth is known as the Ascendant, the most important single consideration used in Vedic Astrology for predictions. From the astrological point of view, for the purpose of charting the planetary positions and calculations etc., the 360 degrees of the zodiac was divided into 12 equal parts, called Rasi or sign, of 30 degrees each. The Zodiac sign which includes the Ascendant is considered as the first house. The sign next to the ascendant (which will raise the next) becomes the second house and so on. The tenth

house in the zodiac sign is exactly on the top (the north direction) at the time of birth. The qualities of the houses are explained in terms of angles (kendras), trines (triconal), upachayas, dustanas, marakas etc. Kendra Bhavas 1, 4, 7, 10 are considered to be most powerful houses of all. They lead to emphatic manifestations in life.

Twelve houses in an Astrology chart, each of which, defines a specific domain or area of our action in life. Each house has assigned with essential traits, features called "karakas" or Significations. Karaka means the doer of certain activities. The most important of all houses is the lagna or the first house. The remaining houses are basically related to the first house only. The planets in the horoscope chart are subservient to the lagna, and their original nature undergoes modifications depending upon the lagna.

Every Bhava has one planet which is called its lord, and the lord of the bhava is always the lord of the sign that falls in that Bhava. For example, Kuja is the lord of Aries, and if Aries falls in the 5^{th} house, then Kuja is lord of the 5^{th} house.

In Vedic Astrology the position and significations of seven planets are considered: the Sun, Moon, Mars, Mercury, Jupiter, Venus and Saturn. Besides Rahu and Kethu are shadowy planets or Chayagrahas. Each planet is a karaka, or indicator (signification), of certain matters, events, characteristics and occurrences in a person's life. All inanimate as well as the animate beings of the world are signified by the planets and hence the word "karaka" is associated with them. These planets govern different significations in the chart according to their nature.

The planets situated in Kendra Bhavas are considered strong and active which help them accomplish their potential. They are sharp, energetic and decisive.

The significations of Kendra Bhavas and Planets are studied on the point of view of above topic carefully and the following significations relating to textile business are noted. Horoscope arrangement favorable for Textile Business

From the above study, it is known that the four Kendra Bhavas play a role of trading and that the Planets, Moon and Venus are more closely related to the textile.

The study of 100 horoscopes made it clear that the Kendra Bhavas, the planets, Moon and Venus are the primary cause in the horoscope for the textile merchants. It has also been proved that they are subject to the following rules.

Rules framed for research

1) Any of Moon or Venus occupy or associate with other Planets in Kendra Bhavas.

2) Lord of Kendra Bhava or Planet occupying Kendra Bhava, is in the star of Moon or Venus.

3) Lord of 10th Bhava occupy the house of Moon or Venus in Navamsa chart.

4) Moon or Venus occupy own or exaltation house either in Rasi or Navamsa chart.

5) Lord of Kendra Bhava occupy the house of, join with or aspected by Moon or Venus.

6) While running Vimshottari Dasa/Bhukthi period of Moon or Venus.

7) Kendra Bhavas set in the houses of Moon or Venus.

Out of the 100 horoscopes studied, the number of horoscopes where the above rules apply is given below.



CONCLUSION

Rules framed

Any of Moon or Venus occupy or associate with other Planets in Kendra Bhavas.

Lord of Kendra Bhava or Planet occupying Kendra Bhava, is in the star of Moon or Venus.

Lord of 10th Bhava occupy the house of Moon or Venus in Navamsa chart.

Moon or Venus occupy own or exaltation house either in Rasi or Navamsa chart.

Lord of Kendra Bhava occupy house of, join with or aspected by Moon or Venus.

While running Vimshottari Dasa/Bhukthi period of Moon or Venus.

Kendra Bhavas set in the houses of Moon or Venus.

Thus, it is concluded that Kendra Bhavas and the Planets Moon and Venus, within the frame of 7 rules, sets the tone of Textile Business in natal Horoscope.
